In consideration of being allowed to participate in any way in the activities of the North Liberty Youth Baseball and Softball league, d/b/a North Liberty Coralville Baseball and Softball, including but not limited to the athletics/sports programs, related events and activities, the undersigned acknowledges, appreciates, and agrees that:

- 1. The risk of injury and/or illness and/or contraction of a virus from the activities involved in the program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce the risk, the risk of injury or contraction of virus does exist;
- 2. The risk to have contact with individuals, who have been exposed to and/or have been diagnosed with one or more communicable diseases, including but not limited to COVID-19 or other medical conditions, diseases, or maladies does exist, and it is impossible to eliminate the risk that I could be exposed to and/or come into contact with and/or become infected through contact with or close proximity with an individual with a communicable disease;
- 3. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown at the time of signing this document and continuing through all times of participation, even if arising from the negligence of the releases or others and assume all and full responsibility for my participation;
- 4. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and
- 5. I, for myself and on behalf of my heirs, assigns, personal representatives, and next of kin, hereby release and hold harmless the North Liberty Youth Baseball and Softball organization d/b/a North Liberty Coralville Youth Baseball and Softball, their officers, officials, agents, volunteers, coaches, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of the premises used to conduct the event ("Releasees"), with respect to any and all injury, illness, disability, death, or loss or damage to person or property, whether arising from the negligence of the releasees or otherwise. By this accord, I hereby assume all risk of injury, illness, disability, or death arising from and including my participation in the league.

I have read this release of liability and assumption of risk agreement, before acknowledging the signatory space below, fully understand its terms, understand that I have given up substantial rights by agreeing to it on my own behalf or on the behalf of the youth participant stated herein, and I sign it freely and voluntarily without any coercion or inducement.
- 7. By acknowledging and agreeing to the signatory space below, I agree to and verify the following:
 - a. I am the parent or legal guardian for the youth participant stated below,

- b. that the date of birth of the youth participant stated below is true and correct,
- that as a parent/legal guardian with legal responsibility for this youth participant, I
 consent and agree to assume all the risks of his/her participation in these programs;

- d. that I specifically agree to his/her release of liability as provided herein to all of the releasees, and, for myself, my heirs, assigns, and next of kin, I release and agree to indemnify the releasees from any and all liabilities incident to this youth participant's involvement or participation in this or any program offered or provided by the releasees even in arising from the negligence of the releasees or otherwise.
